

## Trash Pickup

Per city ordinance, trash should be placed at the curb no earlier than 5pm on Tuesday and no later than 7am on Wednesday. Emptied containers should be removed as soon as possible, but no later than 24 hours after pickup.

# New Troy City Ordinances

### **Snow Emergency**

The City of Troy will declare a snow emergency when snowfall exceeds four inches, necessitating the plowing of subdivision streets. All vehicles must be removed from the roads until either the snow emergency is over or the road is completely cleared. This ensures that plow trucks can operate efficiently and clear the entire roadway. Parking on the street during a snow emergency is prohibited and fineable by up to \$75.

**Bows & Arrows** No person shall discharge any firearm or **bow and** arrow in the City of Troy. A person who violates this section is guilty of a misdemeanor punishable by imprisonment in the county jail for not more than 90 days or by a fine of not more than \$500. Exceptions apply to persons lawfully acting in the defense of persons or property or the enforcement of law or at an established range that has been approved by the Troy City Council.

# **Commons Encroachments**

Encroachments into the commons areas are not permitted by the Raintree Village Homeowners Association. Examples include removing trees or brush, or placing sheds, fire pits, benches, underground and overhead lighting, potted plants, hammocks, shrubs, gardens and compost bins on commons property.

The Board asks homeowners whose property abuts one of the commons areas to check their property surveys and vacate any encroachments they may have made into the commons areas.

### FENCE RULES

The Raintree Village Homeowners Association Declaration of Covenants, Conditions, and Restrictions states that: No fence of any kind shall be permitted to be erected, maintained or placed upon any lot or lot line between the front property line and the front building setback line (this means no fences in front of the house).

RVHA rules for fences are stricter than The City of Troy fence ordinance.

#### **Commons Areas**

Forest, Village, Abbey and Lakeside Commons are the four commons areas within Raintree Village. Lakeside and Abbey Commons have swing sets and benches and Forest and Village Commons have walking trails. Enjoy using these commons areas, but treat them with respect to preserve them. Clean up after your dog and do not litter. Fireworks and fires are not allowed in the commons areas. DO NOT DAMAGE, TRIM OR CUT DOWN ANY TREES OR PLANTS INSIDE THE COMMONS AREAS! Contact RVHA if you discover a commons area maintenance issue.

#### 2025 Dues are \$34

The Raintree Village dues for 2025 are \$34 for the year and are deed mandated. This is a \$1 increase over the 2024 dues. The main cost facing us is the restoration of the shoreline of the detention pond at Lakeside Commons.
